**Narrative**: (provide information)

- 1. Introduction-- Steve welcomed everyone and introductions were made by all present
- 2. Coordinator's Report
  - a. Review Action Items from Feb. 4 Minutes:
    - 1) The 2/4/13 General meeting went well, although attendance might have been down due to the holiday.
    - 2) Pub Science was a success.
    - Steve recognized Walt for continuing to build up our Resources section on our website.
  - b. Budget Update--Steve had e-mailed us the budget and said we would discuss it further in the meeting.
  - c. Mini-Grant Update--Steve reported that all Mini-Grant funds have been spent except for about \$700.
  - d. CSLNet grant—ends 3/31/13; Final report due 4/19/13; John reported Chris Roe indicated CSLNet might be willing to extend grant one to two months.

- 4. Pub Science Update Dawn reported that the next event will be held at the Steinberg Gallery Café on 4/24/13. There will not be an entrance/host fee; however, donations will be solicited. Presentation will be about cheese and possibly ice cream. Anne Marie shared that the following Pub Science presenter will be Tony Frazier, Cal Poly science biology lecturer and researcher. 34 tickets were sold for \$5 each at the March 6<sup>th</sup> Pub Science event. \$3 per ticket went to Creekside. With \$5 missing, the remaining \$40 was given to Julie, the Treasurer. Dawn personally paid for dinner for the speaker and his wife. Dawn and Anne Marie will attend Santa Barbara's Pub Science on 3/25/13.
- 5. Maker's Faire Update CCSTEM participation/presence was discussed; see Action List. CCSTEM will not have a booth.
- 6. Grant Proposal Status Wendy confirmed that the SLO City promotion grant application was submitted. Meeting discussion will provide additional information for Wendy on future grants regarding "who is the applicant?". The \$6,900 grant application was submitted under the name "Science After Dark", so the events will be called "Science After Dark Presents Pub Science". The SLO Children's Museum will be the fiscal agent. Seth reported that his Department Chairman has submitted an application for \$500 to ACS to support Pub Science activities.

7. Board member Paul Turnbull has, according to John, moved to Hawaii and is willing to give up his board position. Walt suggested asking Jaime Foster to serve.

#### 8. What's next?

- a. How will we make CCSTEM North viable and active after CSLNet grant ends? Ideas included the following:
  - 1) Operate within larger organizations such as SLOCOE & Cal Poly.
  - 2) Continue small projects/events, website, and partnerships
  - 3) Continue increasing our membership
  - 4) Connect with other organizations doing similar work
  - 5) Connect with large and small businesses for funds
  - 6) Continue to apply for grants and also provide mini-grants
  - 7) STANDARDIZE THE MESSAGE: Create CCSTEM story, in writing.

Tell same story to partners (on website, in newspapers, to members, the public, donors, etc. Wendy offered to write language; someone else would integrate graphics. A PowerPoint should also be developed for presentations members might make. Include possible benefits for partners.

- b. What should the remaining CSLNet grant funds be allocated for? Ideas included the following:
  - 1) \$500-\$1,000 by May 11<sup>th</sup> for Maker's Faire
  - 2) \$1,500 by May 1<sup>st</sup> for Dawn to attend the June 17<sup>th</sup>-19<sup>th</sup> U.S. News STEM Solutions Conference in Texas to build collaboration and increase visibility
  - 3) \$584 reimbursement for Anne Marie Bergen for attendance at 2012 STEM Conference (per John, this is to be covered by CSLNet)
  - 4) \$1,500 for Wendy Wendt for work accomplished and future work on a PG&E grant application and writing of CCSTEM story.
  - 5) \$? for CCSTEM marketing materials and printing, i.e. buttons for Maker's Faire
  - 6) \$ to continue Collaboration Soup facilitation
  - 7) \$1,780 for fees, insurance, and checks to establish CCSTEM non-profit status within the next couple of months (Group agreed to dedicate a future meeting to discuss only item #7.)
- 9. Closing Comments about What Worked Tonight:
  - a. We're committed to continuing our work.
  - b. Decision to "tell our story."
  - c. Ideas for viability and self-sustainment
  - d. "Rumors of (our organization's) death are greatly exaggerated."
  - e. Clarity about our group's commitment
  - f. Great exchange of information
  - g. Guest, Parke Godar, said we were a "highly functional" group
  - h. Great facilitation, Delia!
  - Gold Star for Steve!

# BRAINSTORM OF HOW TO MAKE CCSTEM VIABLE AND ACTIVE BEYOND THE CURRENT CSLNET GRANT

- 1. Get grants to do projects.
- 2. Become part of larger organization (SLOCOE, Cal Poly, other)
- 3. Larger institutions help SLOCOE will have more staff, so Patti may be more available.
- 4. Pursue public visible activities and get press for them.
- 5. Cal Poly may help with \$3-\$5,000 for admin./clerical coordination
- 6. Bring more people together expand our base
- 7. Facilitate partnerships, partner with colloaboratives
- 8. Add more people to the Board Rita has talked with Carl Bloom, Los Osos Middle School (instituting STEAM program) Principal, to replace her as she is moving back into teaching, and he is willing.
- 9. Keep operations going we have volunteers who are doing things.
- 10. Need funds to support website and operating expense.
- 11. Revisit asset mapping goal Pam thought maybe talk to Exxon about funding this or other projects
- 12. Focus on smaller projects and get larger institutional support or hosting
- 13. Be seen
- 14. Our Board members attend other organizations (examples: Workforce Investment Board, Economic Vitality Corp, Softec). Find out what they are doing that we can support.
- 15. Be recognized as the "go to" org.
- 16. Engage business community more aggressively George is on Cuesta Board and will try to make more of a connection with them.
- 17. Leverage by having an "Executive Road Team" to go to SFO and LAX to meet with big businesses and tell our story (to Exxon, Bechtel, etc.)
- 18. Focus on our strengths in small things with big ipact, e.g. website to connect local resources with needs.
- 19. Leverage what we have
- 20. Get big \$ for targeted items that will also fund some of the admin costs.
- 21. Partner on projects that are "grant" worthy.
- 22. Stay a diverse group and look tactically at grant opportunities where multiple members could apply.
- 23. Evaluate what do we need to do differently to be successful on grants.
- 24. Keep awarding mini-grants when we can.
- 25. Membership dues, maybe a small amount.
- 26. Fund our website.
- 27. Do "cheap" things or do things cheaply.
- 28. Keep going, keep meeting
- 29. Air Force STEM Center

- 30. Approach companies at Vandenberg when we have clear goals and our story.
- 31. Volunteer at no cost
- 32. Attend lunch-time Rotary meetings—will bring funds
- 33. Wendy suggested Mary Verdon to help with story
- 34. Strategize at next meeting specifically how to reach goals
